







Terms and Conditions and Disclaimer

In registering for the International Conference on Earth, Energy & Environmental Sciences for Carbon Neutrality ("ICE3SCN"), delegates, speakers and attendees agree to the following Terms and Conditions:

Registration

<u>Payment</u> – Payable in Hong Kong Dollars (HKD). The exact amount of the registration fee in the registrant's currency will be based on the exchange rate on the date of transaction on corresponding transaction platform. Transaction exchange rates may not always correlate with the most current rates. Registration fee must be paid in full to guarantee registration. Once payment has been received, email confirmation will be sent.

<u>Early Bird Rate</u> – In order to qualify for any "early bird" rates or discounts, registration and payment must be received before the deadline stated in the conference marketing material (i.e. 1 November 2023).

Adjustment of Registration Fees – ICE3SCN Organising Committee reserves the right the review the information provided by the registrant and adjust the registration type and fee if it is found that the information provided has been misrepresented or incorrect. The Secretariat shall notify the registrant concerned for follow up arrangement to complete the registration.

<u>Delegate</u> – If a person is registering on behalf of a delegate(s), it is the responsibility of that person to notify the delegate of these Terms and Conditions for which they will be agreeing on behalf of the delegate. Responsibility also includes providing complete details of the delegate's registration details as confirmed.

Cancellation and Refund Policy

Conference registration cancellation raised in writing to the Secretariat at ice3scn@cuhk.edu.hk on or before 15 November 2023, HKT (GMT+8) is refundable less an administrative fee of 30% of the registration fee. All cancellations will not be deemed to be received until written confirmation from the Secretariat. If you have not received acknowledgement within two (2) working days, please contact the Conference Secretariat at ice3scn@cuhk.edu.hk.

Withdrawal or registration cancellation will not be accepted nor refunded after 15 November 2023, HKT (GMT+8) and registration fee paid cannot be transferred to another person under any conditions.

All refunds will be arranged after the event at ICE3SCN Organising Committee's suggested method within 6 months upon written confirmation from the Secretariat, and applicants shall bear all applicable bank charges, if any.

If a registered delegate does not cancel before 15 November 2023, HKT (GMT+8) in written or fails to attend the conference, no refund will be made.

In the unlikely event of the conference being cancelled, ICE3SCN Organising Committee will refund the registration fee, if applicable (except for force majeure events listed below), but









ICE3SCN Organising Committee will not be liable for any other costs or losses you may incur, whether direct or indirect, due to the postponement and/or cancellation of the ICE3SCN.

Data Protection

All accommodation bookings should be made directly through the conference hotel(s) using the accommodation booking link or reservation form. Expenses incurred by the participants are to be settled by themselves in pre-advanced payment or upon checkout.

Presenters

ICE3SCN shall have no liability for advice given or views expressed by any speaker at the conference or in any material provided to attendees. ICE3SCN may use the speaker's name and presentation materials to promote attendance at the conference. The papers must be objective and completely free of advertising and commercialism. ICE3SCN may record audio, photographs and video of all sessions, and the recording may be produced as part of the overall conference materials. Speakers and delegates consent to the incidental use of their names and likenesses to the extent included in any such publicity material, audio and video. ICE3SCN may reproduce copies of the speaker's presentation (e.g. PowerPoint slides or supporting handouts) on paper and electronically, which may be shown on the conference website. Admittance
